CONCERNED ABOUT THE CLOSING OF CANADA'S VISA OFFICE IN TEHRAN? SO IS THE IRANIAN CANADIAN CONGRESS. HELP US CONVEY THE COMMUNITY'S CONCERN TO THE CANADIAN GOVERNMENT.

On April 29, 2012, the Government of Canada announced that it was closing its Visa Office in Tehran for budgetary reasons. This decision can cause significant delays for our family members seeking visas and was made without consultation with the Iranian-Canadian community. The Iranian Canadian Congress has written to The Honorable Jason Kenney, Minister of Citizenship, Immigration and Multiculturalism, and has urged him to consider the negative effects of this decision.

I am deeply concerned about the Government of Canada's recent decision to close the Visa Office in Tehran.

I am worried that your decision will increase the frustrating backlogs that Iranians face when they want to get visas to visit their families in Canada. I am worried that the government made this decision without consulting with the Iranian-Canadian community. I am worried that this decision will harm Iranian-Canadians and make it harder for them to see their loved ones.

I want to add my voice to many members of the Iranian-Canadian community, including the Iranian Canadian Congress, who have written to members of the Government, including your office, to express their concern.

Please reconsider the decision to close the Visa Office in Tehran.

It is important to our families. It is important to our community. It is important to voters like me.
